

**RULES AND REGULATIONS
REGARDING THE RECTOR'S SCHOLARSHIP FUND
AT THE JOHN PAUL II CATHOLIC UNIVERSITY OF LUBLIN¹**

§ 1

1. The Rector's Scholarship Fund of The John Paul II Catholic University of Lublin (KUL) is the University's Own Fund for scholarship purposes, pursuant to the provisions of Article 420 of the Act of 20 July 2018 Law on Higher Education and Science (Journal of Laws of 2018, item 1668 as amended) and § 92.3 of the Statute of the Catholic University of Lublin.
2. The Rector's Scholarship Fund is intended for KUL student and doctoral student scholarships, which are awarded and paid under the provisions of these Rules and Regulations.

§ 2

1. The Rector's Scholarship Fund at KUL can be created from:
 - (1) a write-off into the costs of educational and scientific activities, in an amount not exceeding 20% of the projected net profit for a given year;
 - (2) donations made by natural and legal persons to the Fund.
2. Scholarships funded by the Rector's Scholarship Fund are awarded depending on the funds available.
3. Rector or an authorised Vice-rector competent for student support determines the amount of the scholarship and the period for which it is granted.
4. Scholarships funded by the Rector's Scholarship Fund is awarded in consultation with the institutional executive body of the student self-government.

§ 3

1. Scholarships funded by the Rector's Scholarship Fund can be awarded for academic achievements in particular to:
 - (1) students or doctoral students participating in national or international research or teaching didactic programmes;
 - (2) students and doctoral students entitled to receive Rector's Scholarship, which cannot be paid from KUL scholarship fund as defined in Article 412 of the Act of 20 July 2018 Law on Higher Education and Science.
2. As provided hereunder, Scholarships may be awarded to foreign students and doctoral students.

§ 4

1. Rector or an authorised Vice-rector competent for student support may withhold the payment of the previously awarded Scholarship in any of the following events:

- (1) Scholarship holder has his or her rights of a student or a doctoral student of KUL suspended;
- (2) Scholarship holder is removed from the list of students or doctoral students of KUL;
- (3) Scholarship holder graduates from KUL (completes studies).

2. The decision to award Scholarship expires on the last day of the month in which the student or a doctoral student of KUL is suspended in his/her rights or removed from the list of students or doctoral students of KUL or has graduated from KUL.
